
### COVID-19 Resources

OSHA continues to update its COVID-19 [webpage](#) with guidance for employers and workers. Recently, OSHA:

- Issued a revised [National Emphasis Program \(NEP\) for COVID-19](#), and an [Updated Interim Enforcement Response Plan \(IERP\)](#) (July 7, 2021). Both documents replaced the March 12, 2021 versions.
- Updated its [Guidance on Mitigating and Preventing the Spread of COVID-19 in the Workplace](#) to align with CDC guidance, and to reorganize appendix recommendations for manufacturing and the meat, poultry, seafood, and agricultural processing industries. (August 13, 2021)
- Published a fact sheet in [English](#) and [Spanish](#) on filing whistleblower complaints related to COVID-19.



Small Business Safety and Health Handbook



### Revised Small Business Handbook

OSHA and the National Institute for Occupational Safety and Health (NIOSH) collaborated in issuing an updated [Small Business Safety and Health Handbook](#) that highlights the benefits of implementing an effective safety and health program, provides self-inspection checklists for employers to identify workplace hazards and reviews important workplace safety and health resources for small businesses. NIOSH also spotlighted the update in a Science Blog post [here](#).

### Heat Illness Prevention

OSHA is implementing a [heat enforcement initiative](#), developing a National Emphasis Program, and launching a rulemaking process to develop a workplace heat standard.

## Keep Teen Workers Safe Initiative

OSHA is participating in a joint social media campaign from October 18 - November 5 to promote health and safety awareness among teens who are employed or will be during the holiday season. ## Hazard Alert: Soybean Soapstock Storage Tank Explosion

OSHA issued a new [hazard alert](#) on a storage tank explosion that killed a welder installing a catwalk on top of the tank. The control of ignition sources is critical at oil and solvent extraction plants.



## Hazard Alert: Diving Operations

OSHA issued a [hazard alert](#) on keeping workers safe during diving operations. Divers working around drains, tunnels, pipes or valves can suffer fatal injuries when differential water pressure, commonly known as Delta P, creates forces quick and strong enough to entrap them.

## Shipyard QuickCard

OSHA published a new QuickCard in [English](#) and [Spanish](#) on the role of the Shipyard Competent Person (SCP) in ensuring safe working conditions.



## Whistleblower Protections for Consumer Product Industry Workers

OSHA issued a fact sheet in [English](#) and [Spanish](#) on whistleblower protections for workers in the consumer product industry under the Consumer Product Safety Improvement Act (CPSIA).

## Keeping Drivers Safe

OSHA published a revised brochure in [English](#) and [Spanish](#) to help employers keep their employees safe behind the wheel.


